# PROVIDENCE COLLEGE Health Policy and Management Program




For more than three decades the Health Policy and Management Program (HPM) at PC has been preparing students for challenging careers in health services management, health policy-making, and public health practice, as well as providing a strong foundation for graduate study. Today, health policy and management is one of PC's most popular areas of study and is part of the new Department of Health Sciences and the School of Nursing and Health Sciences. As the complexity of issues regarding health and healthcare have grown significantly in recent years, so has our program evolved to prepare students to rise to those challenges.

The growing popularity of the HPM Program at PC reflects larger trends in the economy and society. Current employment forecasts suggest that the demand for healthcare services will continue to expand in the coming decades.
